

NOTICE OF RISK AND POLICIES

Talladega Superspeedway has taken enhanced health and safety measures—for you, drivers, crew, vendors, employees and other guests. **An inherent risk of exposure to COVID-19 exists in any public place where people are present, including the event for which you are purchasing admission.** (CDC), you may be especially vulnerable to COVID-19. Guests should evaluate their own risk in determining whether to attend any public event.

As a condition of admission to the event, you will be required to abide by all current facility rules, posted instructions, and protocols while on premises or **risk ejection**, including, but not limited to the following, which may be periodically revised in accordance with public health guidance:

- Guests are required to wear a cloth face covering (all guests who are 3 years or older or for patrons who may need an accommodation in order to comply with any facility rules and/or protocols, please contact or visit our guests services team for further information).
- Guests must submit to a non-contact temperature check prior to entry.
- Guests will be presented with a brief questionnaire prior to entry to confirm that they are not currently experiencing COVID-19-like symptoms and/or have not been recently exposed to the virus.
- Guests must maintain a distance of at least 6 feet (or 2 meters) between their travel party and others.
- Guests are reminded to wash their hands frequently with soap and water

ALL ADMISSION SALES ARE FINAL – NO MONEY REFUNDED – NO EXCHANGES – EVENT DATE & TIME SUBJECT TO CHANGE. In the event of a postponement of the Event, this Admission will be honored on the date the Event is held.
